3. Purpose of Processing

Your data may be processed for the following purposes:

Processing takes place at the controller's premises and/or through trusted service providers (e.g., hosting, email, analytics) located in the **EU, Italy**, or the **United Arab Emirates**, in full compliance with applicable laws.

6. Data Retention

We retain personal data only for as long as necessary to achieve the purposes for which it was collected, or as required by legal obligations.

This includes:

- Data needed to respond to your request
- Retention for legal, administrative, or technical reasons
- Deletion upon your request (where legally permissible)
